At Home Screenings, Exclusions, Quarantines: Parents and older students are expected to complete the required self-assessment each morning. If necessary, the student is expected to stay home until they have met the Return Criteria. Generally, all students are expected to be symptom- and fever-free for 24 hours without medication before returning to school. A health care provider may release a student to return to school as well. The schools will refer to Four Corners for recommendations on exclusions, siblings, and quarantine times.
